Welcome to this public session on climate-related migration to and within the European Region. Lancet Migration is a global collaboration between *The Lancet* and researchers, implementers, and others in the field of migration and health that aims to address evidence gaps and drive policy change, building on the recommendations of the UCL- *Lancet* Commission on Migration and Health published in December 2018 (<https://www.thelancet.com/commissions/migration-health>). Launched in June 2021 and co-hosted by the Geneva Centre of Humanitarian Studies, the Lancet Migration European Regional Hub aims to bring together researchers, civil society, non-governmental bodies, multilateral organisations, policy makers, and migrants themselves across the region to encourage the development of regional research projects and link academia with policy and practice to translate evidence into action. One of the core research priorities for Lancet Migration ([www.migrationandhealth.org](http://www.migrationandhealth.org)) is the climate change, migration, and health nexus. In 2019, the International Organization for Migration defined the term climate migration as, “the movement of a person or groups of persons who, predominantly for reasons of sudden or progressive change in the environment due to climate change, are obliged to leave their habitual place of residence, or choose to do so, either temporarily or permanently, within a State or across an international border”. It is well recognized that climate change is detrimental to planetary health, and disproportionately affects those most vulnerable. Faced with natural disasters, conflict, changing temperatures and affected agriculture practices, people are being increasingly displaced from their homes. Food security, the spread of vector-borne diseases, access to water, sanitation and hygiene, and mental health are some of the many health issues encountered as a result of climate change-related migration. Since 2013, the European Union has identified climate change-related migration as a health policy issue. However, few focused research initiatives have evolved. It is not well understood to what extent health is impacted and how access to health services can be improved in the European Region in response to climate-driven migration. This interactive panel discussion will explore research gaps and opportunities surrounding the health challenges and effects relating to climate change-related migration.

## Speaker Biographies



**Karl Blanchet** is the Director of the Geneva Centre of Humanitarian Studies, and Professor in Humanitarian Public Health at the Faculty of Medicine, University of Geneva. Before joining University of Geneva, Professor Blanchet worked in health systems research at the London School of Hygiene and Tropical Medicine since 2010 and was the co-founder and co-Director of the [Health in Humanitarian Crises Centre](#). Professor Blanchet's research focuses on system resilience and health systems issues in global health, specifically in post-conflict and conflict-affected countries. He has developed

innovative research approaches based on complexity science and system thinking, and is currently focusing on Women, adolescent and Child Health in humanitarian settings. Karl is also developing a priority package of essential health services for countries such as Afghanistan and more generally for humanitarian crises. Karl Blanchet was one of the coPI of the [Lancet Series on Women's and Children's Health in Conflict Settings](#). Professor Blanchet is also the Academic Director of [InZone](#), a University of Geneva academic project offering university courses for refugee populations.
